Weekly service to your property will begin March 1st and end the last week of November. These dates are estimates and can/will fluctuate on need based on weather and current lawn type. Optional services by request can be performed in the off months of Dec, Jan and Feb.

Services included in this Lawn Maintenance Service Agreement are mowing, edging driveways and walkways, trimming around the house, fence, and beds, and blowing the driveway and walk-ways off.

Payments:

We offer multiple payment options to our customers. Cash, check or online payments: PayPal, Venmo or Zelle.

Month in advance is due at signing of service agreement, after that all invoices will automatically be emailed to you the 1st of each month and due no later than the 10th of each month. Invoices more than 10 days past due will incur a late fee of \$10. Invoices 20 days past due will result in suspension of services until all past due is paid in full including late fees.

Client Responsibility:

Allow access to property during reasonable hours for services to be performed. Debris, furniture, toys, lawn ornaments, vehicles, or anything else that will hamper efficient performance of service or cause danger/harm to contractor or contractors equipment is to be removed from turf the night prior to service. Excess pet waste not removed prior to scheduled service day will result in **AN ADDITIONAL FEE OF \$10 PER VISIT**.

If the excess waste becomes a constant issue service may become disrupted or suspended until waste removal is performed properly.

Weather:

In the event of delays due to inclement weather, it is possible that service may be postponed until the following week. Weather delays DO NOT reflect an adjustment of price, as the delay increases difficulty and time in performing services on your property and therefore increases cost of labor.
